

Tuition & Fees for 48-Unit Master's of Science Programs

This information is for engineering/computer science Master of Science programs offered by the USC Viterbi School of Engineering requiring the successful completion of a minimum of 48 units of graduate engineering coursework.

Tuition and fees for the academic year 2025-2026 (2026-27 not yet available) are as follows:

Mandatory Fees (approximate)*	\$847 per semester
Health Insurance for 2024-25 (2025-26 rates not yet available)	Fall Semester – \$1,063 Spring/Summer Semester – \$1,977

* These fees are: student health service, programming, transportation and Topping Student Aid Fund. In the first semester, there is also a one-time \$55 orientation fee.
